

Step by Step Instruction For FM-3 At San Diego Consulate

REQUIREMENTS

1. APPLICANTS MUST APPLY IN PERSON AND MUST BE 55 YEARS OR OVER
2. VALID PASSPORT, ONE PHOTOCOPY OF PASSPORT, PASSPORT MUST HAVE AT LEAST 12 MONTHS OF VALIDITY REMAINING. IF THE PERSON IS NOT A U.S. CITIZEN BESIDES THE PASSPORT, A THE COPY OF THE ALIEN REGISTRATION (PERMANENT RESIDENT IN U.S.A.), WILL ALSO BE REQUIRED.
3. A LETTER FROM YOUR BANK THAT SPECIFIES THE AVERAGE OF YOUR MONTHLY DEPOSIT PLUS THE LAST BANK STATEMENT FROM YOUR ACCOUNT TO VERIFY THAT YOU DO MAKE A MINIMUM DEPOSIT OF \$1000.00 PER MONTH AS THE HEAD OF YOUR FAMILY AND \$500.00 DOLLARS PER DEPENDENT, (OR) THE LAST SIX BANK STATEMENTS FROM YOU ACCOUNT.
(IF YOU HAVE DEPENDENTS YOU MUST ALSO PRESENT A COPY OF THE MARRIAGE CERTIFICATE AND A COPY OF BIRTH CERTIFICATE/S OF MINOR/S.).
4. TWO PASSPORT PHOTOS. (PHOTOS MUST BE RECENT).
5. No automatic machine photos will be accepted.

PROCEDURE

1. Find a place to park. There are several lots in the area. Cost is \$ 2.00 dlls per half hour with a maximum of \$ 15.00 dlls in most cases. If you find a open meter, make sure you move before the two hour time limit. If not, you will be ticketed even though the meter has not expired.
2. Go past the information desk and up the stairs. (ignore the long lines of people waiting outside and the lines on the stairs. They are not there for the same proposes.) Process to windows #1.
3. Obtain an application form and fill it out Completely (available above this document)
4. Return to the window and present the clerk with the application form and all the above listed requirement.

5. The clerk will give you two slips, one for \$ 36.00 dlls for visa and one for \$ 96.00 dlls for the FM-3, totaling \$ 136.00 dlls. Take these to the cashier at window 5. You must pay in cash. No other form of payment is accepted.
6. The cashier will stamp both halves of slips and return one to you. Take this receipt back to the clerk at window 1.
7. The clerk will let you know when your paperwork should be ready. Of you get there before 8:30 am chances are very good that you will receive the FM-3 about 1:00 pm that same day. If you arrive any late than that, you may have to return the next day.
8. To pick up your FM-3 return to window 1, give the clerk your name and be prepared to show identification.
